In particular the consignor is liable for material and legal defects of the consigned object according to the Auction Terms & Conditions. In the event that the object will display major defects after the consignment XEEC is entitled to terminate the present contract.
- 4. There is a handling fee of CHF 480.00 for objects with a limit and CHF 280.00 for objects without a limit (art.1). The fee is due for payment at the time of signing the auction order or at the time of acceptance of the object for auction respectively.

All consigned objects will appear online and in printed form on our website and our media portals.

5. Storage of the object is at the consignor's risk. Risks of loss, theft, damage and destruction are the consignor's responsibility.
